

ACCOMMODATION CONTRACT

GENERAL ACCOMMODATION CONDITIONS :

The reservation is granted on a personal basis. It **cannot be transferred**, **freely or for a fee**, **or exchanged**. The signatory must be an adult. They are responsible for the material entrusted to them and must have Travel and Holiday Civil Liability Insurance (OBLIGATORY).

The amount for the stay must be calculated based on the arrival and departure dates registered on the reservation form. No discount will be granted for late arrival or early departure for any reason.

WARNING: in case of lateness, please advise us. If no information is provided to us, the accommodation may be granted to another client from the following day at 12:00. The fee will not be refunded.

The prices encompass all charges, except the visitor tax in effect, set and received by the regional authorities, invoiced per day and per person over 17 years of age.

The number of people stated for each accommodation is a maximum number (children and babies included). In no case will the accommodation receive more people than the capacity stated in the description. In case of an inaccurate declaration, this contract may be fully terminated, with the amounts paid being retained by the campsite.

The reservation only takes effect after the payment of 30% of the accommodation amount and the reservation fees and the receipt of the correctly completed accommodation contract, signed and approved (which requires the acceptance of the general reservation clauses and provisions).

For all stays, the balance will be paid 30 days before the arrival date. In case of payment not being made by this time, your reservation will be automatically cancelled and the deposit will be kept in full by the campsite. For all reservations made within 30 days before the start date of the stay, full payment is required.

In case of cancellation or interruption of the stay for any reason (illness, accident, etc.), the tenant will be required to pay the balance, and the campsite will not be held liable. No refund will be granted.

Cancellation insurance is not included in the price, and is optional. The tenant is free to contract this insurance. Its amount is not included in the price of the stay. We encourage you to register on the website, <u>www.campez-couvert.com</u>

Tenants must take out insurance from an insurance company against the inherent risks of their occupation: theft, loss or damage to their personal objects, as well as all damage which may be caused to the rented property and the campsite. In case of accident, the campsite refuses any responsibility (except when proven to be due to fault of the campsite).

All tenants, upon arrival, must visit the campsite reception, provide the reservation letter that will have been sent to them by post, and an identity document.

Minors (under 18 years of age) are only accepted if accompanied by their parents and residing with them.

Accommodation available from 15:00 on the day of arrival and **must be departed from at 09:00 at the latest** on the day of departure.

In case of arriving after 19:00, the campsite must be notified.

The tenant must check the accommodation and the inventory on the day of arrival and notify the reception of any anomalies before 12:00 the following day. After this time, any breakage, deterioration or loss will be invoiced.

It is expressly prohibited to use the beds without using bed linen. It is prohibited to smoke inside the accommodation. We do not provide sheets, bed sheets or towels. Disposable bed linen is sold at the campsite shop during its opening hours.

Cleaning of the accommodation is the responsibility of the tenant. At the end of the stay, the accommodation is checked, and must be in a perfect state both inside and in its immediate surroundings (the whole accommodation swept and cleaned, baking trays and oven cleaned, refrigerator **defrosted and cleaned**, the accommodation not requiring the service of a cleaner).

Pets are only authorised when monitored and kept on a leash, and must not be left alone in the accommodation or in its surroundings. They must in no case climb onto the sofas or beds. They must be tattooed and vaccinated. The obligatory vaccination card will be requested on the day of arrival. 1st and 2nd category dogs are not accepted.

It is prohibited to assemble a tent on the terrace of the accommodation.

Visitors must go to reception and pay the fee upon arrival, and their car must remain outside of the campsite.

All individuals staying on or visiting the campsite must respect the interior regulations. The interior regulations of the campsite are those of good neighbourliness and common sense. The interior regulations are posted at the entrance of the campsite. A copy written in French or English may be provided upon request at reception.

All claims related to the services provided must be addressed to the campsite management by registered mail, at the latest one fortnight after the end of the stay.

Signing the contract implies awareness of the content of this document, and a personal understanding of it, and unreserved acceptance of it. Potential litigation resulting from the execution of the accommodation contract, which cannot be resolved amicably, will be subjected to the courts in accordance with the rules of jurisdiction defined in article 49 of the New Civil Procedure Code.

During the stay, the tenant may be asked to appear in videos or photos for the promotion of the campsite. In case of refusal, the campsite must be notified by registered mail before arrival.
